# Brazil: a general view




- 184,2 million Population
- 8,5 million km<sup>2</sup> Area
- Federative country, 26 States, 01 Federal District and 5.564 municipalities
- GDP 2005 R\$ 1.938 bi / U\$ 969 bi
- GDP 2005 Per Capita R\$ 10.520 / U\$ 5.260
- Poor population 11,1 million of families (27,9% of the population) – National Research for Sample of House holds 2004



#### **Income Inequality**


Income Distribution of the 50% poorer part of the population and of the 1% richer part of the population, in relation to the total of income

## **Description - Transference of Income**

- ✓ 1995: Pioneer experiences of Campinas and in the Federal District with conditional cash transfer programs.
- ✓ 1996: Child Labour Eradication Program (PETI)
- ✓ 1998: Guaranteed Minimum Income National National program (Ministry of Education – MEC)
- ✓ 2001: Bolsa Escola ("School Grant"), Bolsa Alimentação ("Food Grant") – Cadastro Único (Single Registry System)
- ✓ 2002: Auxílio Gás ("Cooking Gas Grant")
- ✓ 2003: Cartão Alimentação ("Food Card")




# Bolsa Família Program

- Created in October, 2003 MP (Measure) nº 132, 10/20/2003 – Law nº 10.836, 01/09/2003
- Cooperated and coordinated strategy among the federative entities for the fight against poverty, the promotion of the social inclusion and the support to the families in situation vulnerability.
- Serves the families that are below the poverty line, unifying the remaining programs:
  - Bolsa Escola (School Grant)
  - Bolsa Alimentação (Food Grant)
  - Cartão Alimentação (Food Card)
  - Auxilio Gás (Cooking Gas Grant)



#### Bolsa Família Program



Immediate poverty relief (income) Rupture of the poverty intergerational cycle (conditinalities) Family development (complementary actions)



#### Characteristics

- ✓ National Coverage 100% of municipalities
- ✓ Focus on the family
- ✓ Benefit given preferably to the woman
- Direct payment to the family (magnetic card)
- ✓ Autonomy in the use of the resource



#### Characteristics

- ✓ Family commitment to health and education
- Integration with state and municipal programs
- Participation of the society
- ✓ Monitoring and fiscalization
- Decentralized and intersectorial management







#### Conditionalities

Family counterpart

Access to the health, education and social assistance services as citizenship rights



Monitoring of the conditionalities in order to identify situations of greater social vulnerability and to guide the public power actions



### Conditionalities

Health and nutrition monitoring: for pregnant women and children aged 0 to 7

School attendance above 85% for children and adolescents aged 6 to 15

Social and educational activities: for children in risk of child labour (PETI)

Responsibilities: Bolsa Família managers in association with the Secretariats on Education and Health



# **Bolsa Família Program Evolution**

Couverage Goal/Financial Resources

YEAR	BENEFICIARY FAMILIES	FINANCIAL RESOURCES (R\$/U\$)
2003	3.6 million	3.2 billion – 1.60 billion
2004	6.6 million	5.5 billion – 2.75 billion
2005	8.7 million	6.8 bilhões – 3.40 billion
2006	11.1 million	5.7 billion – 2.85 billion (till September)

The resources used for the program represent 0.3% of the annual GDP.
